(iii) The right, title and interest in the Patent Application and any patent granted in consequence thereof including the right to sue for damages and other remedies in respect of any infringement of said patent

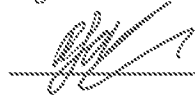
TO HOLD the same unto CROMPTON absolutely

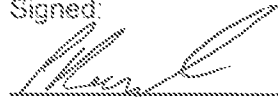

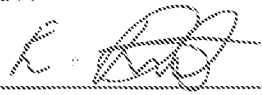
