3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer any and all Letters Patent to ASSIGNEE in accordance herewith.
4. This Assignment is being made under covenant, not only that full power to make the same is had by the INVENTORS, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restrictions, or other right heretofore given.
