THIS AGREEMENT is dated 15th July 2014

Parties

- (1) **Airbus Operations Limited** incorporated and registered in England with company number 3468788 whose registered office is at Pegasus House, Aerospace Avenue, Filton, Bristol, BS99 7AR, United Kingdom ("**Airbus**").
- (2) **Michelin Recherche et Technique SA** incorporated and registered in Switzerland with company number CH-102.674.351 and having its principal place of business at Route Louis Braille 10, CH-1763 Granges-Paccot, Switzerland, and having its director Pierre Varenne duly authorised to represent the company

Compagnie Générale des Etablissements Michelin incorporated and registered in France with company number 855 200 887 R.C.S. Clermont Ferrand having its principal place of business at 12 cours Sablon, 6300 Clermont-Ferrand, France, and having Philippe Legrez, general counsel of Michelin group, duly authorised to represent the company,

(which companies are referred to collectively herein as "**Michelin**").

Airbus and Michelin are referred to collectively as the "**Parties**" and each of them is a "**Party**".

Background

- (A) Airbus is the proprietor of or applicant for the Airbus Patents (as defined below).
- (B) By the Main Agreement (as defined below) Airbus assigned to Michelin a joint ownership interest in the Airbus Patents, and Airbus hereby confirms such assignment to Michelin by this agreement.

Agreed terms

1. Definitions

The following definitions apply in this agreement.

"**Airbus Patents**" means the patents and patent applications, short particulars of which are set out in Schedule 1, and any granted patents issuing from such applications, including any continuations, continuations in part, extensions, reissues, divisions, amendments thereto, including any patents anywhere in the world that are based on or derive priority from the foregoing.

"**Main Agreement**" means the settlement and cross licence agreement dated 28 March 2014 between the Parties.

2. Assignment

Pursuant to and for the consideration set out in the Main Agreement Airbus hereby confirms its assignment to Michelin of such interest in the Airbus Patents as is necessary for both Airbus on the one hand and Michelin on the other hand to be joint owners in equal and undivided shares of the Airbus Patents.

3. Further assurance

Each Party shall, and shall use all reasonable endeavours to procure that any necessary third party shall, execute and deliver such documents and perform such acts as may reasonably be required by the other Party for the purpose of giving such other Party the full benefit of all the terms, conditions and provisions of this agreement.

4. Waiver

No failure or delay by a Party to exercise any right or remedy provided under this agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

5. Counterparts

This agreement may be executed in any number of counterparts, each of which when executed shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.

6. Governing law

This agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

7. Jurisdiction

Each Party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).


This agreement has been entered into on the date stated at the beginning of it.




