NOW, THEREFORE, in consideration of the premises and the mutual representations, warranties, covenants, agreements and conditions herein contained, the parties hereto agree as follows:

Company hereby assigns, transfers, sells and conveys to Parker all of Company's right, title and interest in and to the Patents, together with the exclusive right to enforce the Patents to the full extent allowable in their applicable jurisdictions in the United States and throughout the world in the sole name of Parker, and the exclusive right to sue for and recover for its own use accrued profits and damages for any and all infringements of the Patents, including, but not limited to, past infringements.


