AND ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States of America to issue any and all United States patents which may be granted upon said United States applications or any of them, or upon said INVENTION or any part thereof, to said ASSIGNEES;

AND ASSIGNOR, their successors and assigns, hereby agree to execute without further consideration any further lawful documents and any further assurances, and any divisional, continuing, reissue, or other applications for patents of any country, that may be deemed necessary by said ASSIGNEES fully to secure to said ASSIGNEES their interest as aforesaid in and to said INVENTION or any part thereof, and in and to said several patents or any of them;

AND ASSIGNOR hereby covenants and agrees with said ASSIGNEES, its successors and assigns, that ASSIGNOR has granted no right or license to make, use, or sell said INVENTION, to anyone except said ASSIGNEES, that prior to the execution of this assignment, ASSIGNOR'S right, title and interest in said INVENTION have not been otherwise encumbered, and that ASSIGNOR has not executed and will not execute any instrument in conflict herewith.
