AND We/I hereby covenant for ourselves/myself and our/my legal representatives, and agree with said ASSIGNEE, its successors and assigns, that We/I have granted no right or license to make, use, sell or offer to sell said improvements, to anyone except said ASSIGNEE, that prior to the execution of this deed, our/my right, title and interest in said improvements had not been otherwise encumbered, and that We/I have not and will not execute any instrument in conflict therewith;




