ASSIGNMENT

Box 2463, Houston, TX 77252, has made a certain improvement in HYDROSTATIC PRESSURE TEST METHOD AND APPARATUS (the "Invention") for which application papers for United States Patent thereon, identified as 15/151,309, have been executed on our behalf; and,

NOW THEREFORE, for valuable consideration received, ASSIGNOR hereby sells, assigns, and transfers to ASSIGNEE, its successors and assigns, all right, title and interest in and to said Invention in the United States and in all other countries throughout the world; including without limitation those in and to the above-named application and any continuation, substitute or division application thereof and the patent or patents which may be issued thereon in the United States and any reissue of any such patent, and those in and to any application or patent or utility model in any and all such other countries of the world, and further including the right to file further applications in all countries throughout the world in the name of ASSIGNEE or whomsoever that company may nominate, and to claim the priority of the above-named United States application under the International Convention of Paris of 1883.

With respect to any country where for the filing of such an application and/or the transfer of priority rights a separate deed of sale, assignment or transfer is required, ASSIGNOR will undertake at the request of ASSIGNEE to execute such separate deed to ASSIGNEE or to whomsoever that company may nominate.


