

AND WHEREAS the Assignment is intended to confirm the assignment, transfer and conveyance to Assignee of the Intellectual Property owned by Assignor and used in the Business effective as of the Effective Date;

NOW, THEREFORE, in consideration of the above and other good and valuable consideration including the proceeds received by Assignor, the receipt and sufficiency of which is hereby acknowledged:

- 1. Assignor hereby sells, transfers, conveys, assigns and delivers unto Assignee all of Assignor's worldwide right, title and interest in and to the Intellectual Property, together with all associated goodwill, the same to be held by Assignee as fully and entirely as the same could have been held and enjoyed by Assignor if this Agreement had not been made, including the assignment of the right to take action and recover in respect of any infringement of the rights of Assignor in and to the Intellectual Property that took place prior to the date of this Agreement.
- 2. Assignor hereby authorizes the Australian Intellectual Property Office, Canadian Intellectual Property Office, the United States Patent and Trademark Office, the European Union Intellectual Property Office and any and all other relevant governmental Intellectual Property Offices to transfer and record the assignment of the Trademarks, Copyrights and the Patents to Assignee, as assignee thereof, or otherwise as Assignee may direct.
- 3. Assignor further agrees, from time to time, to make, do, and execute, or cause to be made, done, or executed, all such further acts, deeds, assurances, or things that may reasonably be required to give effect to the foregoing provisions, including the execution of any
