RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is dated as of December 18, 2019, by GOLDMAN SACHS LENDING PARTNERS LLC, in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Collateral Agent") in favor of VIVINT SOLAR, INC. (the "Grantor"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Grantor and the Collateral Agent entered into that certain Security Agreement dated as of March 3, 2015 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Collateral Agent that certain Patent and Trademark Security Agreement dated as of January 26, 2018 (the "Patent and Trademark Security Agreement") and recorded with the United States Patent and Trademark Office on February 7, 2018 at Reel/Frame Nos. 44860/0424 and 6268/0328, pursuant to which the Grantor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the Collateral (as defined in the Patent and Trademark Security Agreement);


WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all right, title, and interest in the Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in and to all of the Collateral, including the issued patents, patent applications, trademark registrations, and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in and to all of the Collateral under the Security Agreement and the Patent and Trademark Security Agreement.


