OF  
TERMINATION AND RELEASE OF SECURITY INTEREST  
IN  
PATENTS**

TO: United States Patent and Trademark Office

Ladies and Gentlemen:

Reference is made to (i) that certain Security Agreement dated as of December 21, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") among LMG HOLDINGS, INC., a Delaware corporation, formerly known as #1 A LIFESAFER HOLDINGS, INC., (the "Company") and certain of its subsidiaries party thereto as Grantors, NORTHSTAR MEZZANINE PARTNERS V L.P., a Delaware limited partnership, ("Northstar"), and HONEYWELL INTERNATIONAL INC. MASTER RETIREMENT TRUST ("Honeywell", and together with Northstar, the "Purchaser") and NORTHSTAR MEZZANINE PARTNERS V L.P., a Delaware limited partnership, in its capacity as Administrative Agent for the Purchaser (in such capacity, "Administrative Agent") and (ii) that certain Patent Security Agreement among #1 A LIFESAFER, INC., formerly known as LIFESAFER INTERLOCK, INC., a Kentucky corporation, (the "Assignor") and the Administrative Agent, dated as of January 24, 2012, which was recorded with the United States Patent and Trademark Office (the "USPTO") on February 15, 2012 at Reel 27705, Frame 0652 (as may be amended, restated, supplemented, or otherwise modified and in effect from time to time, the "Patent Security Agreement").

WHEREAS, in connection with certain indebtedness formerly owed by the Company to the Purchaser, the Assignor entered into that Security Agreement and the Patent Security Agreement pursuant to which Assignor granted a security interest in favor of Administrative Agent in and to certain of Assignor's patent rights listed on Exhibit A hereto (the "Released Patent Collateral").

WHEREAS, said indebtedness owed by the Company to the Assignee has been fully paid and satisfied and in connection therewith, the Administrative Agent is required to terminate and release its security interest in the Released Patent Collateral.

NOW, THEREFORE, the Administrative Agent covenants and agrees as follows:

1. Without recourse, the Administrative Agent automatically and irrevocable terminates, releases and discharges its security interest in the Released Patent Collateral and

reassigns to Assignee all right, title and interest of the Administrative Agent in the Released Patent Collateral pursuant to the Patent Security Agreements and all proceeds thereof.

2. Any security interest or other lien in favor of the Administrative Agent in any assets or property owned by the Assignor has terminated by operation of law.

3. Administrative Agent hereby irrevocably authorizes the recordation of this notice of termination and release with the USPTO.
