PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT AGREEMENT (this "Agreement") is effective as of the date the last party signs the Agreement (the "Effective Date") by and between Revolutionary Concepts, Inc. ("REVO"), a corporation organized and existing under the laws of the State of Nevada and having a place of business 5237 Albemarle Rd., Suite 215, Charlotte, North Carolina 28212 and Eyetalk365, LLC ("Eyetalk"), a limited-liability company organized and existing under the laws of the North Carolina and having a place of business at 12213 Potts Plantation Circle, Cornelius, NC 28031.

WHEREAS, REVO desires to assign any and all Assigned Patents to Eyetalk.

WHEREAS, Eyetalk is desirous of acquiring all right, title, interest, and control in and to the Assigned Patents.

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, REVO and Eyetalk (each a "Party" and collectively, the "Parties") agree as follows:

1. Assignment. REVO, without further remuneration, hereby irrevocably conveys, transfers, and assigns to Eyetalk, and Eyetalk hereby accepts, all of REVO's right, title, and interest in and to the following (the "Assigned Patents"):

(a) the patents and patent applications set forth in Schedule 1 hereto and all inventions, improvements, issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, substitutes, and renewals thereof (the "Patents"), as well as any patent application claiming priority to any of the Patents (including all foreign patent applications that have been or may be filed claiming priority to any of the Patents); and

(b) any and all claims and causes of action with respect to any of the Patents, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. REVO hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Agreement upon request by Eyetalk. Following the date hereof, upon Eyetalk's reasonable request, REVO shall take such steps and actions, and provide such cooperation and assistance to Eyetalk and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as

may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Patents to Eyetalk, or any Eyetalk or successor thereto.

3. Entire Agreement. This Agreement (including any attached Schedule) sets forth the entire agreement and understanding of the Parties relating to the subject matter hereof and merges all discussions, representations, covenants, promises, discussions, negotiations, and exchanges between them with respect thereto.

4. Modification and Waiver. No modification of or amendment to this Agreement will be effective unless in writing signed by authorized representatives of both Parties. No waiver of any rights is to be charged against any Party unless such waiver is in writing signed by an authorized representative of the Party so charged.

5. Counterparts. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment.

6. Successors and Assigns. This Patent Assignment shall be binding upon and shall inure to the benefit of the Parties hereto and their respective successors and assigns.

7. Governing Law. This Patent Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Patent Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of North Carolina, without giving effect to any choice or conflict of law provision or rule (whether of the State of North Carolina or any other jurisdiction).
