

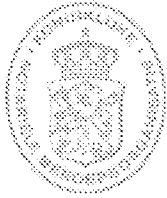

This **INTELLECTUAL PROPERTY ASSIGNMENT** ("Assignment") is made as of the 31st day of October, 2019 ("Effective Date") by and between the following Parties, pursuant to the Agreement for the Sale and Purchase of Assets ("Purchase Agreement"):

Assignors are the following, with respect to the specific Intellectual Property ("IP") assets owned by the named entity: Prolyte Group B.V., Prolyte Holding B.V., Prolyte Sales B.V. and Prolyfi B.V., each a private company with limited liability (besloten vennootschappen met beperkte aansprakelijkheid) organised under the laws of the Netherlands and with registered office and principal place of business at Leek, the Netherlands (each an "Assignor with respect to its IP assets"); and each duly represented herein by Mr. J.C.M. Silvius q.q., having his offices at Van Elmpstraat 2, (9723 ZL) Groningen, the Netherlands, at the offices of de Haan Advocaten & Notarissen, in his capacity as trustee in bankruptcy in the involuntary liquidations of the foregoing private companies "Trustee"; and

Assignee is Step by step management B.V., a private company with limited liability (besloten vennootschap met beperkte aansprakelijkheid), organised under the laws of the Netherlands, having its corporate seat (statutaire zetel) in 's-Gravenhage, the Netherlands, and with business address at: Louis Couperusplein 2, 2514 HP 's-Gravenhage, the Netherlands, registered with the trade register of the Dutch Chamber of Commerce (Kamer van Koophandel) under file number: 76200493, duly represented by its sole director F. Zykan.

NOW, THEREFORE, for good and valuable consideration of 100 Euros and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each Assignor hereby irrevocably assigns and transfers to Assignee, its successors and assigns, in perpetuity all right, title, and interest in and to its trademarks, trade names, service marks, domain names, taglines, social media handles, patents, patent applications, utility model patents, design rights, technology, inventions (whether now known or hereinafter invented), trade secrets, licensed rights, copyrights, and know-how throughout the world (the "Intellectual Property"), including its registered and unregistered trademarks, trade names, and service marks and applications and registrations therefor (collectively, "Marks"), together with the goodwill of the business symbolized by the Marks, as well as its registered and unregistered copyrights, domain names, and social media accounts, including but not limited to the properties set forth in Attachment A and as may be hereafter located or discovered. The rights assigned include, but are not limited to, any choses in action relating to said Intellectual Property and claims for damages, profits and costs, both in equity and law, for any infringement or infringements of said Intellectual Property accruing or occurring on, before or after the date of this Assignment.

Each Assignor further agrees to execute or provide such other documents and take other actions as Assignee or its representatives may reasonably request, as necessary to effectuate the purpose of this Assignment, without further consideration. In order to facilitate the recordation of the assignment of the Intellectual Property with the relevant national administrations and in particular with the China National Intellectual Property Administration, the Assignors undertake

to sign, execute and deliver to the Assignee all the required original documents and certificates, forms, checklist and information for the recordation of the Intellectual Property with the above mentioned administrations, together with a Power of Attorney by Assignor Prolyte Group B.V. or its authorized agent or administrator, to Assignee's counsel within 5 working days from the execution of the Assignment.

Each Assignor hereby promises that it will not withdraw the IP assignment or any recordation application, or revoke any of the assigned IP rights.

The Parties further acknowledge that Attachment A may be further modified by adding additional IP assets which may be identified hereafter, and consent to the modification of Attachment A for such purpose without further consent. Each Assignor hereby designates the Assignee, and any successor or transferee thereof, as Assignor's attorney-in-fact without further authorization or designation, for the purposes set forth in this provision, and for the purposes of signing and executing any documents or powers of attorney as may be required in connection with the assignments and recordation thereof with the relevant national administrations.

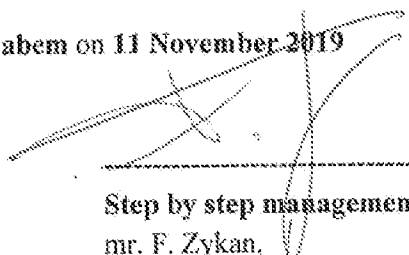
