ASSIGNMENT AND AGREEMENT

For value received, We, Syed A. M. Tofail residing at 26 Castletroy View, Childers Road, Limerick, Ireland, and James Butler, residing at Gortavoher, Aherlow, Co. Tipperary, Ireland., hereby sell, assign, and transfer to the **University of Limerick**, a body established by the Universities Act 1997 of Plassey Technological Park, Limerick, Ireland, and its successors, assigns, and legal representatives, hereinafter collectively "UL", the entire right, title and interest, for the United States of America, in and to certain inventions related to **"METHOD OF FORMING A SINTERED NICKEL-TITANIUM-RARE EARTH (NI-TI-RE) ALLOY"** described in Great Britain Application Serial No. 1118208.6 filed on 21 October 2011 and any and all applications claiming the benefit thereof including the right of priority, and described in U.S. Application Serial No. 13/656,151 filed on October 19, 2012, and all the rights and privileges in said application and under any and all Letters Patent or any continuation, division, renewal, or substitute thereof, and any reissue or re-examination thereof that may be granted in the United States for said inventions; and we also concurrently hereby sell, assign and transfer to UL, the entire right, title and interest in and to said inventions for all countries foreign to the United States, including all rights of priority arising from the application aforesaid, and all the rights and privileges under any and all forms of protection, including Letters Patent, that may be granted in said countries foreign to the United States for said inventions. WE sell, assign, and transfer this right, title and interest as of the day of signature or of filing of the British patent Application mentioned above, whichever is the earlier.

We authorize UL to make application for such protection in its own name and maintain such protection in any and all countries foreign to the United States, and to invoke and claim for any application for patent or other form of protection for said inventions, without further authorization from us, any and all benefits, including the right of priority provided by any and all treaties, conventions, or agreements.


