ASSIGNMENT

WHEREAS, GENENTECH, INC., a corporation organized and existing under the laws of the state of Delaware, located at 1 DNA Way, South San Francisco, CA 94080, hereinafter referred to as "Assignor", is the owner of certain rights, title and interest in the invention set forth in the below-identified patent applications:

for which an application Serial No. 10/983,340 for Letters Patent has been filed by them on November 5, 2004; and International Patent Application No. PCT US04/038392 has been filed by them on November 6, 2004

WHEREAS, SEATTLE GENETICS, INC., a corporation organized and existing under and by virtue of the laws of the State of Delaware, having a place of business at 21823 - 30TH Drive SE, Bothell, WA, hereinafter referred to as "Assignee", is desirous of acquiring Assignor's entire right, title and interest invention, and in and to the Letters Patents to be obtained therefor;

NOW, THEREFORE, be it known by all whom it may concern;

That for good and valuable consideration the receipt of which is hereby acknowledged, the said ASSIGNOR has and does hereby sell, assign, transfer and set over unto Assignee, its successors and assigns, the full and exclusive right, title and interest including all rights under the Paris Convention for the Protection of Industrial Property, in and to said invention, and in and to any and all Letters Patents to be granted and issued therefor or any continuation, division, renewal, or substitute thereof, and as to Letters Patents any reissue or re-examination thereof, not only for, to, and in the United States of America, its territories and possessions, but for, to and in all other countries; and it has been and is hereby authorized and requested that the appropriate government agencies issue said Letters Patents to Assignee, in accordance with this Assignment.

Said ASSIGNOR covenants and agrees to cooperate with Assignee, to enable said Assignee to enjoy to the fullest extent the right, title and interest herein conveyed in the United States and foreign countries. Such cooperation by said ASSIGNOR includes prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by said Assignee, (a) for perfecting the right, title and interest herein conveyed; (b) for prosecuting any of said applications; (c) for filing and prosecuting applications for reissuance of any of said patents; (d) for interference or other priority proceedings involving said invention; and (e) for legal proceedings involving said invention and any applications therefor and any patents granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the expense incurred by said ASSIGNOR in providing such cooperation shall be paid for by said Assignee.

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid,

to issue the same to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

Assignor covenants and agrees that it has a full right to convey its entire right, title and interest herein assigned.

The terms and covenants of this assignment shall inure to the benefit of said Assignee, its successors, assigns and other legal representatives, and shall be binding upon said Assignor, its respective heirs, legal representatives and assigns.

Said Assignor hereby warrants and represents that they have not entered and will not enter into any assignment, contract, or understanding in conflict herewith.
