**TERMINATION AND RELEASE OF SECURITY INTEREST**

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of December 19, 2019 ("Release"), is made by ARES CAPITAL CORPORATION ("Agent") in favor of TOTES ISOTONER CORPORATION ("Grantor").

**WHEREAS**, Agent, Grantor, and the other parties thereto have entered into that certain Security Agreement, dated as of May 1, 2014 (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

**WHEREAS**, pursuant to that certain Patent Security Agreement, dated as of May 1, 2014, by and between Agent and Grantor (the "Patent Security Agreement"), Grantor granted to Agent, to secure its obligations under the Security Agreement, a lien on and security interest in all right, title and interest of Grantor in and to certain Intellectual Property Collateral;

**WHEREAS**, the Patent Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") at Reel 032803/Frame 0363 on May 1, 2014; and

**WHEREAS**, Grantor has satisfied the terms of the Patent Security Agreement and requests a specific release of the lien and security interest granted and recorded against its Intellectual Property Collateral.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Patent Security Agreement or the Security Agreement, as applicable.

**SECTION 2. Termination and Release.** Agent, without representation, warranty, or recourse, hereby:

(a) terminates the Patent Security Agreement and terminates, cancels, discharges, and releases all of its liens on, and security interests in and to all right, title and interest of Grantor (and any of the borrowers or other obligors under the Security Agreement) in and to all Intellectual Property Collateral (including, but not limited to, all Patent Collateral), whether granted pursuant to the Patent Security Agreement or otherwise (and including, but not limited to, the Patents listed on Schedule A attached hereto);

(b) assigns and transfers to Grantor all of its right, title and interest in and to all Intellectual Property Collateral, whether granted pursuant to the Patent Security Agreement or otherwise (including, but not limited to the Patents listed on Schedule A attached hereto); and


(c) authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Agent has caused this Termination and Release of Security Interest to be duly executed as of the date first set forth above.
