INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("IP Assignment"), dated as of August 31, 2019 ("IP Assignment Effective Date"), is made by and between **TiNi Aerospace Inc.**, with offices and a place of business located at 2505 Kerner Blvd., San Rafael, CA, U.S.A. ("COMPANY") and **Ensign-Bickford Aerospace & Defense Company** ("EBA&D") with offices and a place of business located at 640 Hopmeadow Street, Simsbury, CT, U.S.A.

1. Assignment of Intellectual Property. In consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to applicable export control laws, rules and regulations, COMPANY agrees to convey, transfer and assign, and hereby conveys, transfers and assigns to EBA&D, and EBA&D hereby accepts, all of each such Assignor's domestic and foreign right, title and interest, as of the IP Assignment Effective Date and thereafter, in and to all (i) inventions, discoveries and ideas, whether patentable or not, and all patents, registrations and applications thereto, including without limitation divisions, continuations, continuations-in-part, reexaminations, reissues, extensions and renewal applications; (ii) published and unpublished works of authorship, whether copyrightable or not, copyrights therein and thereto and registrations and applications thereto, and all renewals, extensions, restorations and reversions thereof; (iii) confidential and proprietary information, trade secrets and know-how, including, without limitation, technical data packages, formulae, processes, compounds, drawings, designs, industrial designs, blueprints, surveys, reports, manuals, operating standards and customer lists; (iv) software and contract rights relating to computer software programs, in whatever form created or maintained; (v) all other intellectual property rights or proprietary rights and claims or causes of action arising out of or related to any infringement, misappropriation or other violation of any of the foregoing throughout the world, including, without limitation, rights to recover for past, present and future violations thereof and any and all products and proceeds of the foregoing (collectively "Intellectual Property"); and (vi) **any and all of the foregoing assigned in the name of an entity COMPANY**. Specifically included in the Intellectual Property assigned by COMPANY to EBA&D are all of the issued patents and patent applications listed in the attached **Exhibit A**.

2. Recordation and Further Actions. Upon EBA&D's reasonable request, subject to applicable export control laws, rules and regulations, COMPANY will take such steps and actions, and provide such cooperation and assistance to EBA&D, and its legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Intellectual Property to EBA&D.
