**RELEASE AND TERMINATION
OF SECURITY INTEREST IN PATENT COLLATERAL**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN PATENT COLLATERAL, dated as of January 8, 2020 (this “Release”), is made by GUGGENHEIM CREDIT SERVICES, LLC, a Delaware limited liability company, acting in its capacity as agent (in such capacity, the “Administrative Agent”) under that certain Patent Security Agreement, dated as of March 15, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Patent Security Agreement”), by and between THREEWIRE, INC, (the “Grantor”) and the Administrative Agent. Capitalized terms used herein without definition are used as defined in the Patent Security Agreement.

WHEREAS, pursuant to the Patent Security Agreement which was recorded in the records of the United States Patent and Trademark Office on March 16, 2017 at reel 041590, frame 0257, the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a Security Interest in and to, all of Grantor’s right, title and interest in, to and under its owned or thereafter acquired Patent Collateral, including those Patents set forth on the attached Schedule I;

WHEREAS, the Secured Obligations secured by the Patent Collateral have been repaid; and

WHEREAS, pursuant to that certain Payoff Letter, dated as of January 8, 2020, by and among the Grantor, the other signatories party thereto and the Administrative Agent, the Grantor has requested that the Administrative Agent, and the Administrative Agent has agreed to, (a) release any and all Security Interests it may have in the Patent Collateral pursuant to the Patent Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, for itself and for the benefit of the Secured Parties, does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the Security Interest created under the Patent Security Agreement in the Patent Collateral, (b) release and relinquish its Security Interest in the Patent Collateral, and (c) discharge any and all rights, title and interest it has in and the Security Interest granted to the Administrative Agent in the Patent Collateral. The Administrative Agent agrees, or authorizes the Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantor to evidence the release and termination of the Administrative Agent’s security interests in the Patent Collateral.


