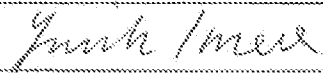
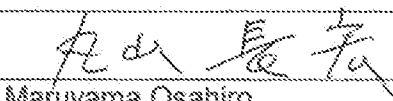
ASSIGNMENT DEED
