**CONFIRMATORY INTELLECTUAL PROPERTY DEED OF ASSIGNMENT**

**THIS DEED** is made the 31 December 2019 (the **Deed**)

**BETWEEN**

- (1) **VASCULAR SOLUTIONS ZERUSA LIMITED**, a private limited company incorporated in Ireland (no. 493999) whose registered office is at Galway Business Park, Dangan, Co. Galway, Ireland (the **Assignor**); and
- (2) **TELEFLEX LIFE SCIENCES LIMITED**, a company incorporated in Malta (company registration no. C94305) whose registered office is at 171 Old Bakery Street, Valletta, VLT 1455, Malta (the **Assignee**),

each a **Party** and together the **Parties**.

**WHEREAS**

- A. The Assignor has assigned the Intellectual Property Rights (as defined below) to the Assignee on the date of this Deed.
- B. In this context, the Parties have agreed to enter into this Deed.

**NOW IT IS HEREBY AGREED** as follows:

1. The definitions and rules of interpretation in this clause apply in this Deed:

**Intellectual Property Rights** means the registered trademarks, patent applications, and patents set out in Schedule 1, as well as unregistered rights in trademarks and service marks associated with Assignor.

2. In consideration of the sum of €1.00 (one Euro) (receipt and sufficiency of which the Assignor expressly acknowledges), the Assignor hereby confirms the assignment to the Assignee all its rights, title and interest including all Intellectual Property Rights.
3. The transfer and assignment confirmed at clause 2 shall include, without limitation: (a) all such right, title and interest, rights of action, powers and benefits arising or accruing from ownership of the Intellectual Property Rights, including without limitation all rights to bring any proceedings and obtain any remedy in respect of any infringement of the Intellectual Property Rights, irrespective of when such infringement occurred or occurs; (b) the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Intellectual Property Rights which includes the right to sue and collect for past damages; (c) all rights to claim priority (where applicable); (d) all rights to any continuations, continuations-in-part, divisions, extensions, amendments, conversions, re-issues, re-examinations, renewals, extensions or restorations of and/or registrations granted in respect of the Intellectual Property Rights; (e) all statutory and common law rights attaching to the Intellectual Property Rights and the goodwill of the Assignor relating to the Intellectual Property Rights; and (f) all other such right, title and interest as the Assignor has in the Intellectual Property Rights for the full term thereof.
4. If any provision or part-provision of this Deed is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause shall not affect the validity and enforceability of the rest of this Deed.
5. If any provision or part-provision of this Deed is invalid, illegal or unenforceable, the Parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision.


This Deed and any non-contractual obligations arising out of or in connection with it shall be governed by and construed in accordance with the laws of Ireland.

6. No variation of this Deed shall be effective unless it is in writing and signed by the Parties (or their authorised representatives).
7. The Parties irrevocably agree that the courts of Ireland are to have exclusive jurisdiction to settle any disputes which may arise out of or in connection with this Deed and that, accordingly, any legal action or proceedings arising out of or in connection with this Deed may be brought before the Irish courts.
8. This Deed may be executed in any number of counterparts and by the Parties to it on separate counterparts, each of which so executed and delivered will be an original, but all counterparts will together constitute one and the same instrument.
9. This Deed shall be binding on, and enure to the benefit of, the Parties to this Deed and their respective personal representatives, successors and permitted assigns, and references to any Party shall include that Party's personal representatives, successors and permitted assigns.




