Pursuant to Title 8, Section 264 of the Delaware General Corporation Law (the “**DGCL**”) and Title 6, Section 18-209 of the Limited Liability Company Act (the “**Act**”) of the State of Delaware

Maya Merger Sub II, LLC, a Delaware limited liability company (“**Merger Sub II**”) and a wholly owned subsidiary of Buyer (as defined below), does hereby certify as follows:

FIRST: Merger Sub II is a Delaware limited liability company duly organized and existing under the laws of the State of Delaware and S2 Systems Corporation, a Delaware corporation (the “**Company**”), is a corporation duly organized and existing under the laws of the State of Delaware.

SECOND: An Agreement and Plan of Merger, dated as of December 31, 2019 (the “**Merger Agreement**”), by and among Cloudflare, Inc., a Delaware corporation (“**Buyer**”), Maya Merger Sub I, Inc., a Delaware corporation and a wholly owned subsidiary of Buyer, Merger Sub II, and the Company, setting forth the terms and conditions of the merger of the Company with and into Merger Sub II (the “**Merger**”), has been approved, adopted, executed and acknowledged by each of the surviving limited liability company and the merging corporation in accordance with Section 264(c) of the Delaware General Corporation Law.

THIRD: The name of the surviving limited liability company in the Merger (the “**Surviving LLC**”) shall be Maya Merger Sub II, LLC, which name shall be amended as set forth in Article Fourth below.

FOURTH: The Certificate of Formation of Merger Sub II, as in effect immediately prior to the merger, shall be amended to change the name of the Surviving LLC to S2 Systems, LLC, and, as so amended, shall be the certificate of formation of the Surviving LLC.

FIFTH: An executed copy of the Merger Agreement is on file at 620 Kirkland Way, Kirkland, WA 98033, the place of business of the Surviving LLC.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving LLC, on request and without cost, to any stockholder of the Company or any member of Merger Sub II.

SEVENTH: The Merger is to become effective at 3:02 a.m. Eastern time on January 1, 2020.

IN WITNESS WHEREOF, Merger Sub II has caused this Certificate of Merger to be executed in its name as of December 31, 2019.
