ASSIGNMENT

PARTIES:

- (1) Jimmy VAN WILTENBURG
of Syncom B.V., Kadijk 3, 9747 AT Groningen, The Netherlands
("ASSIGNOR")
- (2) Syncom B.V. (incorporated in The Netherlands)
of Kadijk 3, 9747 AT Groningen, The Netherlands
("ASSIGNEE")

RECITALS:

- A. The ASSIGNEE is the employer of the ASSIGNOR. The ASSIGNOR is a co-inventor of the patent applications particularised in the Schedule (the "APPLICATIONS").
- B. The parties have agreed that all rights in the APPLICATIONS should be assigned to the ASSIGNEE.

OPERATIVE TERMS:

In consideration of the sum of UK£1 (one UK pound sterling) paid by the ASSIGNEE to the ASSIGNOR (the receipt and sufficiency of which is hereby acknowledged) IT IS AGREED as follows:

1. Assignment

The ASSIGNOR hereby assign to the ASSIGNEE and the ASSIGNEE hereby accepts all the ASSIGNOR's property, right, title and interest in and to the APPLICATIONS including without limitation:

- (a) the APPLICATIONS and all patent applications, patents and supplementary protection certificates which may derive or result from the same, including any divisionals, continuations, reissues, extensions and registrations in relation to any thereof and all and any other rights in the inventions comprised in the above (together referred to as the "PATENT RIGHTS");
- (b) the benefit of all priority dates;
- (c) the right to seek and obtain registrations in all other countries worldwide in respect of any patents deriving from the APPLICATIONS or otherwise included in the PATENT RIGHTS;
- (d) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past, present or future) of the APPLICATIONS or of the rights conferred by publication of the same or of any of the PATENT RIGHTS.

2. Authorisation

The ASSIGNOR hereby authorise the ASSIGNEE and the ASSIGNEE's agents to sign all such forms on behalf of the ASSIGNOR as the ASSIGNEE considers appropriate in order to record the APPLICATIONS and any other PATENT RIGHTS in the name of the ASSIGNEE.

3. Further assurance

The ASSIGNORS shall, at the request and expense of the ASSIGNEE, use all reasonable endeavours to do or procure to be done all further acts and things and execute or procure the execution of all other documents as the ASSIGNEE may from time to time reasonably require for the purposes of giving the ASSIGNEE the full benefit of the assets, rights and benefits transferred to the ASSIGNEE by reason of this Assignment.

4. Law and jurisdiction






