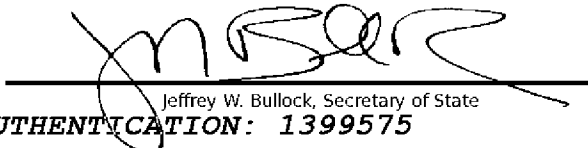

CERTIFICATE OF INCORPORATION

WaveConnex, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "*Corporation*"), hereby certifies that:

1. The name of the Corporation is WaveConnex, Inc.
2. The Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware on August 3, 2009.
