ASSIGNMENT

Further, the Assignor agrees that, upon request and without further compensation, but at no expense to the Assignor, he and his legal representative(s) and assigns will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, sustaining, reissuing or enforcing any design, industrial design, utility model, design patent or patent right as may issue anywhere in the world for said Design, and for

perfecting, recording or maintaining the title of the Assignee, its successors and assigns, to said Design, said applications, and any rights granted for said Design anywhere in the world.



The Assignor authorizes and requests the commissioners or registrars of designs, industrial designs, utility models, design patents or patents of all jurisdictions to issue any design right or design patent granted for said Design, whether on said Application or on any subsequently filed division, continuation, continuation-in-part or reissue application, to the Assignee, its successors and assigns, as the assignee of the entire interest in said Design.


