MASTER SERVICES AGREEMENT

In the event of a conflict between this Agreement and a SOW, the terms contained in this Agreement shall govern and control.

6. Ownership

A. Except as specifically set forth herein and upon full payment to HUGE, the Developed Content shall be considered "work made for hire," under United States copyright law and any and all copyrights, trademarks, and legal protections in such materials shall be the exclusive property of Company; provided, however, that to the extent the Developed Content is deemed not to be "work made for hire," HUGE hereby irrevocably assigns, grants, transfers, and relinquishes all right, title and interest in and to the Developed Content to Company, including the sole and exclusive

HUGE further agrees that it will execute any and all documents, at Company's expense, that may be necessary to perfect Company's right in and to the Developed Content. "Developed Content", as used herein, shall include all Deliverables, inventions, creative materials, plans and ideas, text, graphics, still images, video images and sounds developed by HUGE pursuant to this Agreement for which Company is invoiced. The Developed Content shall not include commercially available software required for the development, maintenance or implementation of a Deliverable, Third-Party Materials, or Tools (defined below).


