WHEREAS, I, Darren Spaziani ("Assignor"), a citizen of Italy, have invented a new, original, and ornamental design for a

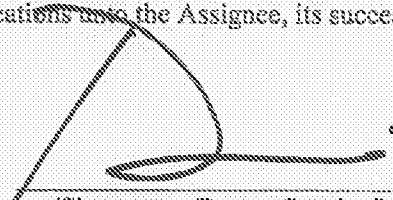
HANDBAG (NEW WAVE CHAIN)
