Patent Business Agreement

This agreement is made on 9/4/19 by and between Mike Simmons (Seller) and David Michalski and Elif Michalski (Buyer).

Buyer agrees to pay Seller the sum of \$20,000 with the first payment of \$6500 due on 9/4/19 of which \$2500 has already been paid, \$4500 due on 9/23/19, \$4500 due on 10/7/19, and the last payment of \$4500 will be due on 10/21/19.

Seller agrees to the following:

1) Seller will grant Buyer an additional 10% overall ownership interest in Mike Simmons's patents to include but not limited to U.S Patent No. 10,309,596 BE, US Patent No. 9,754,466 B2; and US Patent No. 9,685,054 B2 and any products developed from the patents, thereby giving Buyer a total ownership interest of 10% overall which includes any modifications or amendments to the patents or products developed by or for Seller or any entity controlled directly or indirectly by Seller or in which Seller has any interest.

2) Seller agrees that Buyer will receive 20% overall of any sale price or gross revenue generated from any patents or products developed by or for Seller or any entity controlled directly or indirectly by Seller or in which Seller has any interest and sold or licensed to JCI or any other company.

3) Seller agrees pay Buyer 15% overall of any gross income generated from any patents or products developed by or for Seller or any entity controlled directly or indirectly by Seller or in which Seller has any interest and IdeaPros.

4) Buyer and Seller agree to share equally in the ownership of the wall plate, any light bulb that includes an adjustable lumens and/or wattage features, one and/or two piece switches and/or outlets (including but not limited to one, two, three, and four gang switches and outlets), extended power pack, and/or smoke detector and/or any modifications or variations of these products developed by or for Seller or any entity controlled directly or indirectly by Seller or in which Seller has any interest.
