ASSIGNMENT OF INVENTION RIGHTS

- Any and all applications for patent for any of the Inventions that may be or have been filed in any and all countries;
- Any and all patents that may be or have been obtained for any Invention in any and all countries;
- Any reissue, reexamination, extension, renewal, substitution, conversion, confirmation, division, continuation, nonprovisional, provisional, continuation-in-part and the like of any of the foregoing;
- Any application claiming priority to any of the foregoing;
- Any past or present right or cause of action arising with respect to any of the foregoing, including any right to sue for patent infringement, and any copyright in any embodiment of an Invention and any derivative right thereof; and
- Any right received by Assignor, or otherwise held by Assignor, from or related to an inventor with respect to of any of the foregoing,

(hereinafter collectively “Invention Rights”).

FURTHERMORE,

Assignor hereby covenants and agrees, and to the extent legally able binds itself and any and all applicable persons, legal representatives, nominees, and assigns, to assist and cooperate with Assignee—conditioned upon Assignee’s request and at Assignee’s expense—in the preparation and prosecution of any application included within the Invention Rights and in the prosecution or defense of any interference, opposition, or other trial or proceeding that may arise in connection with any of the Invention Rights to the extent such assistance and cooperation is necessary in completing the related task(s) for which the assistance/cooperation is requested. Assignor further hereby covenants and agrees, and to the extent legally able binds itself and any and all applicable persons, legal representatives, nominees, and assigns, to assist and cooperate with Assignee—conditioned upon Assignee’s request and at Assignee’s expense—to execute and deliver to Assignee any and all petitions, oaths, assignments, or other papers or instruments that may be requested by Assignee in connection with the Invention Rights.

Assignor hereby authorizes and empowers Assignee to invoke and claim for any application or patent included within the Invention Rights the benefit of any rights to which Assignor may be entitled under international law or under the laws of any particular country, and to invoke and claim such rights without further written or oral authorization from Assignor.

Assignor hereby consents and agrees that a copy of this “ASSIGNMENT OF INVENTION RIGHTS” (hereinafter “Assignment”) shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document that may be required in any particular country for any purpose and, more particularly, in proof of the right of Assignee to claim the aforesaid benefit of the right of priority and the right to file for patent.

Assignor covenants and agrees that this Assignment and all the terms thereof shall inure to the benefit of the successors, assigns, and nominees of Assignee, without further written or oral authorization from Assignor.

Assignor further hereby represents and warrants: that Assignor has the full power and authority to enter into this Assignment and to fully perform all of obligations of Assignor arising under this Assignment; and that there is no agreement between Assignor and any third party relating to any of the Invention Rights that is in conflict with this Assignment.

This Assignment is governed by and shall be construed in accordance with the laws of the State of Delaware. To the extent one or more provisions of this Assignment are found invalid or unenforceable with respect to a particular national jurisdiction, the other provisions of this Assignment shall continue to apply in the particular national jurisdiction. Moreover, such finding in the particular national jurisdiction shall not affect the validity or enforceability of any provision of this Assignment in any other national jurisdiction.
