## ASSIGNMENT OF PATENT RIGHTS

This ASSIGNMENT OF PATENT RIGHTS (this "Assignment") is entered into as of the 10<sup>th</sup> day of September, 2018 (the "Effective Date"), by and between FTI Consulting Technology LLC, a Maryland limited liability company ("Assignor"), and Nuix North America Inc., a Delaware corporation ("Assignee").

**A.** Assignor and Assignee are parties to that certain Asset Purchase Agreement dated as of the Effective Date (the "Asset Purchase Agreement").

**B.** Pursuant to the Asset Purchase Agreement, Assignor has agreed to sell, transfer, assign, convey and deliver to Assignee, and Assignee has agreed to acquire and accept from Assignor, all of Assignor's right, title and interest in and to the patents and patent applications described on **Schedule A** hereto (the "Transferred Patents") and all of the Assumed Liabilities associated therewith.

**C.** The Asset Purchase Agreement provides that as a condition to the consummation of the transactions contemplated thereby, the parties hereto shall execute and deliver this Assignment to the other parties hereto.

NOW, THEREFORE, in consideration of the transactions contemplated in the Asset Purchase Agreement and the covenants and promises herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Capitalized Terms. Unless otherwise defined herein, capitalized terms have the meanings set forth in the Asset Purchase Agreement.

2. Assignment. Assignor hereby irrevocably sells, assigns, transfers, conveys and delivers to Assignee, and Assignee hereby receives, acquires, accepts and assumes (as applicable) from Assignor, all of Assignor's right, title and interest in and under any and all of the following (collectively, the "Patent Rights") and all the Assumed Liabilities associated therewith:

(a) all Transferred Patents and their foreign counterparts;

(b) all issuances, reissues, reexaminations, extensions, continuations, continuations in part, continuing prosecution applications, requests for continuing examinations, divisionals, and registrations of any item in the foregoing category (a);

(c) all rights accruing under any item in any of the foregoing categories (a) and (b) to apply in any or all countries of the world for patents, certificates of invention, utility models, industrial design protections, design patent protections, or other governmental grants or issuances of any type including, without limitation, under the Paris Convention for the Protection of Industrial Property, the International Patent Cooperation Treaty, or any other international convention, treaty, agreement or understanding throughout the world;

(e) all claims and causes of action and other enforcement rights accruing under any item in any of the foregoing categories (a) through (c), to the extent arising or relating to actions or events following the Closing, including, without limitation, all claims and causes of action and other enforcement rights for (1) damages; (2) injunctive relief, and (3) any other remedies of any kind for past, current, and future infringement, misappropriation, violations, misuse, breach or default, including, without limitation, the right to sue and to collect or otherwise recover any such damages; and

(f) all rights to collect royalties, fees, income and other payments accruing under or on account of any item in any of the foregoing categories (a) through (c), in each case, to the extent arising or relating to actions or events following the Closing.

3. Authorization of Governmental Agencies. Assignor, on behalf of itself and its Affiliates, hereby authorizes the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office and the officials of any other applicable patent office or governmental agency in any applicable jurisdiction to record and register this Assignment upon request of Assignee. Following the date hereof, upon Assignee's request and at Assignee's cost and expense, Assignor shall take, and shall cause its applicable Affiliates to take, such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including, without limitation, the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Transferred Patents to Assignee or any successors and assigns thereto.

4. Miscellaneous. All of the terms and provisions of this Assignment will apply to, be binding in all respects upon and inure to the benefit of the parties hereto and their respective successors and assigns. None of the provisions of this Assignment shall be varied or terminated except by written agreement of the parties hereto. If any provisions of this Assignment shall be held invalid or unenforceable by any court of competent jurisdiction, the remainder of this Assignment shall not be affected thereby and each other term, covenant, condition, and provision shall be valid and enforceable to the fullest extent permitted by law. This Assignment may be signed in any number of counterparts (including counterparts delivered by facsimile or electronic transmission), each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument. The headings contained in this Assignment are for reference purposes only and shall not affect in any way the meaning or interpretation of this Assignment.

5. No Third-Party Beneficiaries. This Assignment is for the sole benefit of the parties hereto and their permitted successors and assigns, and nothing herein expressed or implied shall give or be construed to give to any Person, other than the parties hereto and such successors and assigns, any legal or equitable rights, remedy or claim hereunder.

6. Governing Law. This Assignment shall be interpreted and construed in accordance with the laws of the State of Delaware. Any and all claims, controversies, and causes of action arising out of or relating to this Agreement, whether sounding in contract, tort, or statute, shall be governed by the laws of the State of Delaware, including its statutes of

limitations, without giving effect to any conflict-of-laws or other rule that would result in the application of the laws of a different jurisdiction.
