becoming involved in interference, to cooperate to the best of the ability of the undersigned in the matters of preparing and executing the preliminary statement and giving and producing evidence in support thereof. This Assignment shall be binding upon my heirs, executors, administrators and/or assigns, and shall inure to the benefit of the heirs, executors, administrators, successors and/or assigns, as the case may be, of said Assignee.

And for said consideration, the undersigned hereby agree to execute, at the request of said Assignee, all documents in connection with any application for U.S. or foreign letters patent therefore.
