**RELEASE OF SECURITY INTERESTS
(Trinity Capital Investment, LLC)**

This Release of Security Interests ("Release") is entered into as of January 24, 2020 by Trinity Capital Investment, LLC ("Trinity"), located at 3075 W Ray Rd., Chandler, AZ 85226, in favor of Shelfbucks, Inc. ("Shelfbucks"); CAC, LLC ("CAC"); and BLE Solutions, LLC ("BLE"), all of which are located at 4350 La Jolla Village Dr., Suite 320, San Diego, CA 92122, and is based on the following facts:

1. Trinity was previously a secured creditor of an entity known as Goliath Solutions, LLC ("Goliath"). In its capacity as a secured creditor of Goliath, Trinity filed (a) in the office of the Delaware Secretary of State various UCC-1 financing statements against Goliath; and (b) in the United States Patent & Trademark Office ("USPTO") certain notices of assignment with respect to various patents. Attached hereto in Exhibit A is a summary of the interests in patents that Trinity filed in the USPTO.

2. Goliath subsequently defaulted on its financial obligations to Trinity, as well as its financial obligations to another creditor known as Vogen Funding ("Vogen"), which also had a security interest in certain assets of Goliath. Pursuant to an agreement between Trinity and Vogen, Vogen's security interest in the collateral was senior to that of Trinity. On April 1, 2003, Goliath conducted a UCC foreclosure sale with respect to its security interest in Goliath's assets. At the foreclosure sale, the collateral that secured Goliath's obligations to Trinity and Vogen was acquired by Osa Acquisition, LLC ("Osa"), and Trinity's security interest in the collateral, including the patents described in Exhibit A, was wiped out.

3. Osa thereafter sold certain of the foreclosed collateral, including the patents described in Exhibit A, to Shelfbucks. Shelfbucks then granted a security interest in those patents to Tom Dammeyer, acting in his capacity as Representative for various noteholders of Shelfbucks. Dammeyer then assigned his rights and obligations as Representative to CAC, which is wholly-owned by Dammeyer.

4. In 2019, Shelfbucks defaulted on its obligations to the various noteholders for whom Dammeyer, and later CAC, served as Representative. On July 9, 2019, CAC conducted a foreclosure sale with respect to its security interest in the assets of Shelfbucks. As a result, CAC acquired ownership of various assets of Shelfbucks, including Shelfbucks' interest in patents described in Exhibit A.

5. CAC subsequently transferred its interest the assets foreclosed upon by CAC, to BLE. BLE now wishes to sell the Foreclosed Assets, including the Patent Portfolio, to a buyer ("Buyer"). The Buyer requires that the Patent Portfolio be transferred to Buyer free and clear of all encumbrances, including Trinity's security interest, which is still on file and of record in the USPTO.

6. Trinity hereby acknowledges that it has no further interest in any of the assets of Goliath, Osa, Shelfbucks, CAC or BLE. Accordingly, Trinity hereby agrees to release all such security interests, including Trinity's security interests of record in the patents described in Exhibit A.

7. Trinity further consents to have BLE file this Release, and any other appropriate documentation reasonably necessary to demonstrate that Trinity has released the foregoing security interests, with the USPTO and the Delaware Secretary of State.

NOW, THEREFORE, Trinity hereby releases, discharges, and relinquishes all of its security interest in assets of Goliath, Osa, Shelfbucks, CAC and BLE, including any and all security interest in the patents described in Exhibit A hereto.

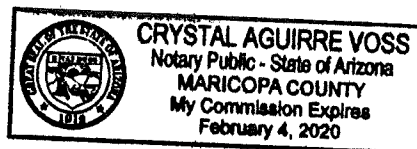
