

A third claim was made by and on behalf of decedent's spouse, Daniel Jenkins, who filed Renunciation of Will on April 24, 2019, and Motion for Accounting of Real and Personal Property on May 8, 2019. A Withdrawal of Renunciation and Release of Claim of Any Interest in Estate was filed in this matter by Daniel Jenkins on December 19, 2019. (Doc. #51).
- 5. The decedent did leave instructions in her Will for all property to be transferred to her mother, Petitioner, Maureen M. Ingram, in ITEM 2 of the Will.
- 6. There are no estate taxes owing the United States of America or the State of Mississippi.
- 7. All other terms and provisions of the Last Will and Testament of Lindsey A.

  Dargusch have been completed, and Maureen M. Ingram, as sole beneficiary of decedent's estate, is the only interested and necessary party to the Petition.

Ingram is discharged from serving as Executrix and this estate is fully and finally closed.


