application, inventions and improvements, for their sole use, to the full end of the term for which such LETTERS PATENT may be granted;

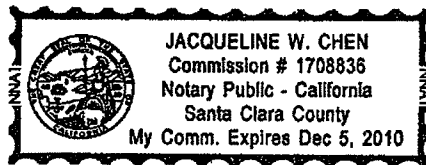

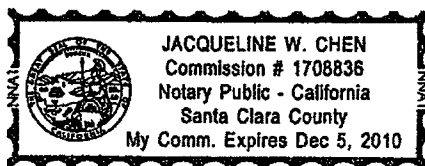
