
ASSIGNMENT

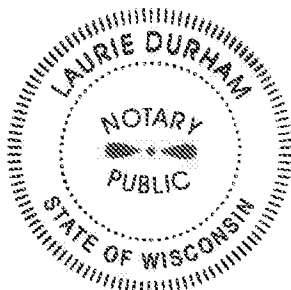


