RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is given as of February 7, 2020 to Horizon Hobby, LLC, a Delaware limited liability company (the "Company"), by CIBC BANK USA, formerly known as The PrivateBank and Trust Company (in its individual capacity "CIBC"), as administrative agent ("Administrative Agent") for certain lenders.

WHEREAS, Company and certain of its affiliates ("Grantors") and Administrative Agent entered into an Intellectual Property Security Agreement dated May 26, 2017, which was recorded in the United States Patent and Trademark Office on June 5, 2017 at Reel 6076, Frame 0628 (the "Security Agreement") pursuant to which Grantors granted to Administrative Agent a security interest in certain intellectual property, intellectual property identified on Exhibit A to this Release (such intellectual property identified on Exhibit A hereto is the "Released Intellectual Property");

WHEREAS, (a) the Trademark set forth on Exhibit A was not at the time the Security Agreement was executed, and is not currently, owned by the Grantors, but is subject to that certain License Agreement dated as of July 19, 2007, as amended by that certain Addendum to License Agreement dated as of October 28, 2010, each by and between by Bachmann Industries, Inc., a Pennsylvania corporation and Company (the "License Agreement"), and (b) the Patent set forth on Exhibit A was not at the time the Security Agreement was executed, and is not currently, owned by the Grantors, but is owned by Traxxas, L.P., a Texas limited partnership;

WHEREAS, the company has certain licensing and other rights in the Released Intellectual Property in accordance with the License Agreement (the "Licensing Rights"); and

WHEREAS, Company has requested that Administrative Agent release its security interest in and liens upon the Released Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

Company hereby represents and warrants to Administrative Agent that it does not own the Released Intellectual Property.

In reliance on the foregoing representation and warranty, Administrative Agent hereby releases its lien on and security interest in the Released Intellectual Property. Notwithstanding the foregoing, Administrative Agent retains its security interest in Grantors' Licensing Rights. The foregoing release shall not be deemed a release of any other intellectual property collaterally assigned by Company or any of its affiliates to CIBC or Administrative Agent, whether under the Security Agreement or otherwise.


