AND ASSIGNOR hereby agrees for himself and for each of his heirs, executors and administrators to execute without further consideration any further documents and instruments which may be necessary, lawful and proper in the prosecution of said above-referenced application or in the preparation or prosecution of any continuing, substitute, divisional, renewal, reexamination or reissue application or in any amendments, extensions or interference proceedings, or other applications for patents of any region or country, that may be necessary to

secure to ASSIGNEE its interest and title in and to said Improvements or any part(s) thereof, and in and to said several patents or any of them;



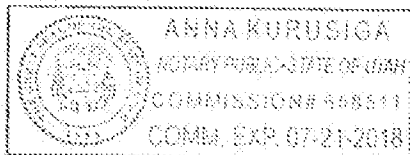


