**PATENT ASSIGNMENT AGREEMENT**

This Patent Assignment Agreement (this “**Patent Assignment**”), dated as of December 13, 2019, is entered into between IntraFuse, LLC, a Delaware limited liability company (“**Assignor**”) and Conventus Orthopaedics, Inc., a Delaware corporation (“**Assignee**”).

**WHEREAS**, Assignor and Assignee are parties to an Asset Purchase Agreement entered into as of the date hereof (the “**Agreement**”), pursuant to which Assignor agreed to sell, assign, transfer, convey and deliver to Assignee, and Assignee agreed to purchase from Assignor, all right, title, and interest in and to the patents and patent applications identified on the attached Exhibit C (the “**Patents**”); and

**WHEREAS**, Assignee is desirous of acquiring all of Assignor’s rights in the Patents, including the applications identified on Exhibit C.

**NOW, THEREFORE**, for good and valuable consideration received by Assignor from Assignee, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignment of Patents. Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee, its successors and assigns, all rights, title, and interest in and to the Patents and patent applications identified on the attached Exhibit C, together with all related inventions, processes, methods, machines, devices, systems, manufactures, and/or compositions of matter, or new and useful improvements thereof; all applications, provisional and non-provisional, to which the Patents claim priority, and divisional, continuation, continuation-in-part, and continuing prosecution applications that claim priority thereto; any reexamination and reissue applications thereof; the right to claim priority to the filing date of applications for the Patents; any provisional, non-provisional, continuation, continuation-in-part, divisional, international, foreign, regional and convention applications corresponding thereto, and any and all Letters Patent of the United States and countries and regions foreign thereto which may grant or have granted thereto or be filed or lodged in relation thereto, any reissue or reexamination thereof or to be obtained therefor, any renewals, or substitutes thereof, and in and to any and all priority rights or priority claims, International Convention rights, any and all rights to collect past damages for infringement of any and all Letters Patent of the United States and countries and regions foreign thereto which may be published, which may grant, or have granted thereto or be filed or lodged in relation thereto, and other benefits accruing to or to accrue to Assignor with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto. Assignor hereby authorizes the appropriate empowered officials at the United States Patent and Trademark Office to transfer the Patents to Assignee as assignee of the entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this instrument of assignment.

2. Counterparts. This Patent Assignment may be signed in counterparts, which together shall constitute one agreement. If this Patent Assignment is signed in counterparts, no party shall be bound until both parties have duly executed, or caused to be duly executed, a counterpart of this Patent Assignment.


**UPON SAID CONSIDERATION**, the Assignor hereby covenants and agrees with the said Assignee that it will not execute any writing or do any act whatsoever conflicting with these presents, and that it will, at any time upon request, without further or additional consideration, but at the expense of the said Assignee, execute such additional assignments and other writings and do such additional acts as said Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining any original, provisional, non-provisional, continuation, continuation-in-part, continuing prosecution, divisional, renewal, reissue, reexamined or extended patent applications and Letters Patent of the United States, or of any and all foreign countries, on said Patent Rights, and execute confirmatory assignments or acknowledgments of this assignment as necessary for full enjoyment of the Patent Rights and for recording in foreign patent offices, and in enforcing any rights or choses in action accruing as a result of such Patent Rights, by giving testimony in any proceedings or transactions involving such Patent Rights, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties;

**UPON SAID CONSIDERATION**, Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest in the Patent Rights, and that Assignor has not conveyed nor will convey hereafter all or part of the Patent Rights to a third party;

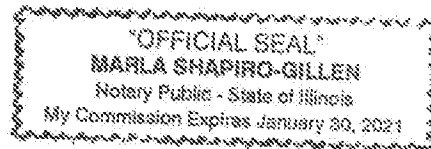
