**THIRD:** The name of the surviving limited liability company is Gift Solutions LLC.

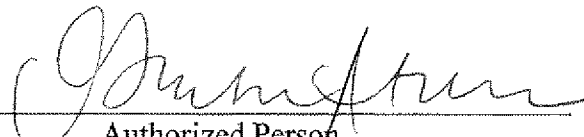
