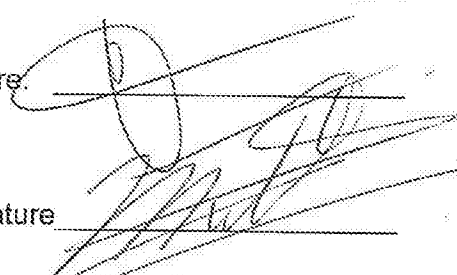

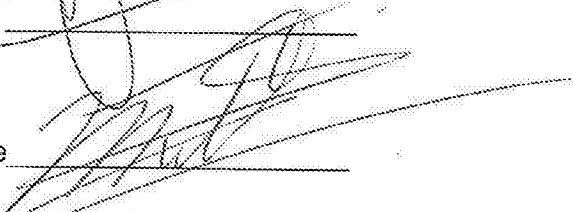

1. The procedure

1.1. On 19 August 2019, a declaration of bankruptcy was filed by the debtor with the registry of this court.

1.2. The hearing in the chambers took place on 3 September 2019.

1.3. In the presence of: Mr A.M. Kleeven.

2. The assessment

2.1. In view of the provisions of Article 3(1) of Council Regulation (EC) No 1346/2000 on insolvency proceedings (hereinafter referred to as IVO), the court has jurisdiction to open these insolvency proceedings since the core of the debtor's main interests is located in the Netherlands.

2.2. The court finds that what has been stated in the declaration has shown in summary form the existence of facts and circumstances which give rise to the presumption that the debtor is in the situation of having ceased to pay.

2.3. The declaration of bankruptcy applied for should therefore be granted.

3. The decision

The court

3.1. declares bankrupt: Mito Medical Products B.V.;

3.2. appoints as supervisory judge Mr B.R.M. de Bruijn, member of this court;

3.3. appoints Mr H.A.W. van Wel, attorney at law, with offices at 6001 BD Weert, Emmasingel 38, as trustee;

3.4. orders the trustee to open letters and telegrams addressed to the bankrupt;

3.5. understands that the Netherlands is the Member State within the meaning of Article 3 of the IVO in which insolvency proceedings are opened.

This judgment was delivered by M.M. Vanhommerig, Judge, and pronounced in public on 3 September 2019 at 10.13 a.m. in the presence of the Registrar.

1. De procedure

- 1.1. Op 19 augustus 2019 is bij de griffie van deze rechtbank een aangifte tot faillietverklaring gedaan door schuldenaar.
- 1.2. De behandeling in de raadkamer heeft plaatsgevonden op 3 september 2019.
- 1.3. Daarbij is verschenen: de heer A.M. Kleeven.

2. De beoordeling

- 2.1. De rechtbank is gelet op het bepaalde in artikel 3 lid 1 van de Verordening 1346/2000 van de Raad van de Europese Unie betreffende insolventieprocedures (hierna IVO) bevoegd deze insolventieprocedure te openen nu het centrum van de voornaamste belangen van schuldenaar in Nederland ligt.
- 2.2. De rechtbank stelt vast dat uit hetgeen in de aangifte is gesteld, summierlijk is gebleken van het bestaan van feiten en omstandigheden, op grond waarvan kan worden aangenomen dat de schuldenaar verkeert in de toestand van opgehouden hebben te betalen.
- 2.3. De gevraagde faillietverklaring dient dan ook te worden toegewezen.

3. De beslissing

De rechtbank

- 3.1. verklaart in staat van faillissement: Mito Medical Products B.V.;
- 3.2. benoemt tot rechter-commissaris mr. B.R.M. de Bruijn, lid van deze rechtbank;
- 3.3. stelt aan tot curator mr. H.A.W. van Wel, advocaat, kantoorhoudende te 6001 BD Weert, Emmasingel 38;
- 3.4. geeft last aan de curator tot het openen van aan gefailleerde gerichte brieven en telegrammen;
- 3.5. verstaat dat Nederland de lidstaat in de zin van artikel 3 IVO is waar de insolventieprocedure is geopend.
