This assignment is considered effective as from November 11, 2009.

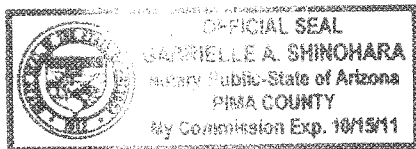
