INTELLECTUAL PROPERTY ASSIGNMENT

THIS ASSIGNMENT is made on _____ 2016

BETWEEN:

- (1) **ICAP SERVICES NORTH AMERICA LLC**, a limited liability company organised and existing under the laws of the State of Delaware, USA with its principal place of business at Harborside Financial Center, 1100 Plaza Five, Jersey City, NJ 07311, USA and registered no. 2828113 (the "**Assignor**"); and
- (2) **INTERCAPITAL SERVICES NORTH AMERICA LLC**, a limited liability company organised and existing under the laws of the State of Delaware, USA with its principal place of business at Harborside Financial Center, 1100 Plaza Five, Jersey City, NJ 07311, USA and registered no. 5928112 (the "**Assignee**").

THE PARTIES AGREE as follows:

1. DEFINITIONS

In this Assignment:

"Encumbrance" means any mortgage, charge (fixed or floating), pledge, lien, option, right to acquire, right of pre-emption, assignment by way of security or trust arrangement for the purpose of providing security or other security interest of any kind (including any retention arrangement), or any agreement to create any of the foregoing; and

"Registered Intellectual Property Rights" means the registrations and applications listed in the Schedule to this Assignment of which the Assignor is the registered proprietor.

2. ASSIGNMENT

In consideration of the sum of £1 now paid by the Assignee to the Assignor (the receipt of which the Assignor hereby acknowledges) the Assignor hereby assigns and transfers to the Assignee absolutely with full title guarantee, free from Encumbrances:

- 2.1 all of its right, title and interest in and to the Registered Intellectual Property Rights including all statutory and common law rights and powers, liberties and immunities attaching to the Registered Intellectual Property Rights;
- 2.2 the right to sue for and to recover damages and other remedies in respect of any infringement of the Registered Intellectual Property Rights which may have occurred before the date of this Assignment; and
- 2.3 any goodwill attaching to the Registered Intellectual Property Rights.

3. FURTHER ASSURANCES

The Assignor shall on request by the Assignee in writing, do and execute or arrange for the doing and executing of, each necessary act, document and thing reasonably within its power to give effect to this Assignment.

4. **GOVERNING LAW**

4.1 This Assignment is governed by English law.

4.2 The courts of England have exclusive jurisdiction to settle any dispute arising from or connected with this Assignment.

5. **COUNTERPARTS**

This Assignment may be executed in any number of counterparts, each of which when executed and delivered is an original and all of which together evidence the same agreement.

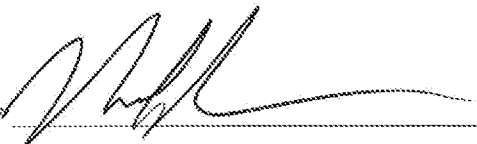

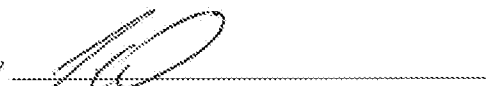
