ASSIGNMENT

2. LUMITEC is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTORS or in the name of LUMITEC or otherwise as LUMITEC may deem advisable, under the International Convention or otherwise.

3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer all said Letters Patent to LUMITEC in accordance herewith.

4. This Assignment is being made under covenant, not only that full power to make the same is had by the INVENTORS, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restriction, or other right heretofore given.

The INVENTORS agree that they will do all acts reasonably serving to assure that said inventions, patent applications and Letters Patent shall be held and enjoyed by LUMITEC as fully and entirely as the same could have been held and enjoyed by the INVENTORS if this Assignment had not been made, and particularly to execute and deliver to LUMITEC all lawful documents including without limitation petitions, specifications, oaths, assignments, invention disclaimers, lawful affidavits, and declarations in form and in substance which may be requested by LUMITEC, to furnish LUMITEC with all facts relating to said inventions or the history thereof and any and all documents, photographs, models, samples or other physical exhibits which may be useful for establishing the facts of conception, disclosure and reduction to practice of said inventions, and to cooperate with LUMITEC and counsel and testify in any proceedings relating to said inventions, patent applications and Letters Patent.

6. INVENTORS hereby request that LUMITEC or its counsel enter or correct the filing date(s) of the afore-referenced Patent Application and enter or correct the Application Serial No. if available (and enter or correct any other information), prior to recording this assignment, to have the same effect as if entered prior to execution of this Assignment.

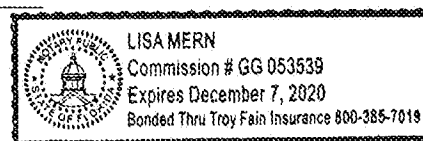
