**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of February 12, 2020 by **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 555 Mission Street, Suite 900, San Francisco, California 94105 (the “**Bank**”), in favor of **PEBBLE TECHNOLOGY, CORP.**, a Delaware corporation with offices at 900 Middlefield Road, Redwood City, California 94063 (the “**Grantor**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of April 20, 2015, as amended by a First Amendment to Intellectual Property Security Agreement dated as of August 26, 2016 (as may be further amended, modified, restated, replaced, or supplemented from time to time, the “**Agreement**”), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the (i) Patent and Patent Applications (“**Patents**”), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on August 29, 2016, at Reel 039861, Frame 0381, (ii) Trademark and Trademark Applications (“**Trademarks**”), notice of which was recorded with the USPTO on August 29, 2016, at Reel 5866, Frame 0488, and (iii) Copyright and Copyright Applications (“**Copyrights**”), notice of which was recorded with the United States Copyright Office (“**USCO**”) on August 30, 2016, Receipt Number 1-1TDQIUY.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Patents, Trademarks and Copyrights (as defined in the Agreement) as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO and USCO to evidence the release of the Bank’s security interests in and liens on the Patents, Trademarks and Copyrights as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in Grantor’s right, title and interest in, to and under the Patents, Trademarks and Copyrights, and all goodwill associated therewith, including, without limitation, those Patents, Trademarks and Copyrights identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO and the USCO.
