## RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release"), dated as of March 2, 2020, is made by FIFTH THIRD BANK, NATIONAL ASSOCIATION, as successor in interest to all rights and obligations of MB FINANCIAL BANK, N.A., a national banking association, as Agent, a national banking association having a place of business at 6111 North River Road, Rosemont, Illinois 60018, ("Agent") in favor of Cosmetic Laboratories of America, LLC, a Delaware limited liability company ("Grantor") having a place of business at 20245 Sunburst Street, Chatsworth, CA 91311. Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Credit Agreement or the Intellectual Property Security Agreement (as those terms are defined below).

WHEREAS, Grantor and Agent are parties to a Loan and Security Agreement dated as of December 30, 2011 (either as amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Loan Agreement");

WHEREAS, Grantor and Agent are parties to a Patent, Trademark and License Agreement dated as of December 30, 2011 (as amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Security Agreement"), recorded with (i) the Trademark Division of the United States Patent and Trademark Office ("USPTO") beginning at Trademark Reel 027591, Frame 0451 and (ii) the Patent Division of the USPTO beginning at Patent Reel 027591, Frame 0451;

WHEREAS, pursuant to the Security Agreement, the Grantor pledged to Agent, for the benefit of the Secured Parties, a security interest (referred to in this Release as the "Security Interest") in the Grantor's right, title and interest in, to and under certain intellectual property of Grantor, including those Patents and Trademarks referred to on Schedules A, B and C hereto (collectively, the "Intellectual Property Collateral").

WHEREAS, Agent has agreed to terminate and release all of its right, title and interest in or to the Intellectual Property Collateral, including the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Agent, for itself and on behalf of the Secured Parties, hereby irrevocably terminates, extinguishes, cancels, releases and discharges any and all right, title and interest, including the Security Interest, in and to the Intellectual Property Collateral arising in connection with the Loan Agreement and Security Agreement and assigns, discharges, quit claims and relinquishes unto Grantor any and all right, title and interest it has in and to the Intellectual Property Collateral.

2. Further Assurances. Agent shall take all further actions, and provide to the Grantor and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.


3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the state of Illinois without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.

4. Recordation. Agent authorizes and requests the Commissioner of the USPTO and any other applicable governmental authority to record this Release.
