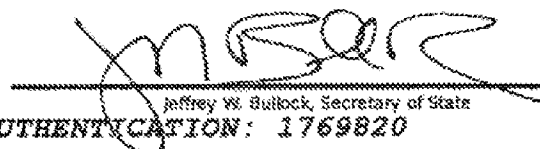

FIRST: The Board of Directors of the Company, by unanimous written consent of its members, a copy of which has been filed with the minutes of the Company, adopted the following resolution proposing an amendment to the Certificate of Incorporation of the Company:
