WHEREAS, the below named inventors have invented certain improvements in the invention as set forth in the application for U.S. Letters Patent set forth above;

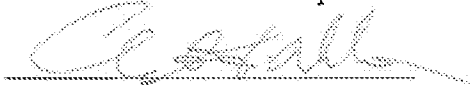
