THIRD: The name of the surviving corporation is Roche Sequencing Solutions, Inc., a Delaware corporation.

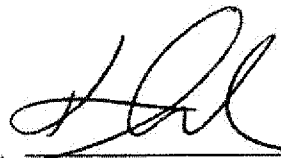
FOURTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
