

ASSIGNOR will communicate to ASSIGNEES, their respective successors and assigns or their representatives, any facts known to us respecting said invention and improvements; and, at the expense of ASSIGNEES, ASSIGNOR will fully cooperate in any legal proceedings, including any proceeding within the United States Patent and Trademark Office or other Patent Office anywhere in the world, relating thereto, sign all lawful papers, execute all non-provisional, divisional, continuing, continuations-in-part, reissue and substitute applications, make all rightful oaths and declarations, and, in addition, execute any and all documents required to vest title in ASSIGNEES and to aid ASSIGNEES to obtain and enforce proper protection for said invention in all countries.

ASSIGNOR covenants that ASSIGNOR has the full right to convey the interest assigned by this Assignment, and that ASSIGNOR has not executed and will not execute any agreement in conflict with this Assignment.

This Assignment shall be binding on the parties' successors, assigns and legal representatives.
