## CONFIRMATORY ASSIGNMENT

WHEREAS **LOEC, Inc.**, a corporation organized and existing under the laws of the State of Delaware, and having a business address at 714 Green Valley Road, Greensboro, NC 27408 (hereinafter **ASSIGNOR**), owned or owns the Transferred IP Assets set forth in **Schedules A & B** hereto;

(an affiliate of **ASSIGNOR**) and Imperial Tobacco Group PLC (an affiliate of **ASSIGNEE**), and an Intellectual Property Assignment (dated 12 June 2015) between the Lorillard Asset Owners (comprising **ASSIGNOR**) and **ASSIGNEE**, the Lorillard Asset Owners agreed to transfer or cause to be transferred to **ASSIGNEE** all of **ASSIGNOR**'s right, title, and interest in and to the Transferred IP Assets set forth in **Schedules A & B** hereto;

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, said **ASSIGNOR** hereby confirms that it has assigned and/or hereby assigns unto **ASSIGNEE**, its permitted successors and assigns, all of **ASSIGNOR**'s right, title, and interest in and to the Transferred IP Assets set forth in **Schedules A & B** hereto, including all reissues, divisions, continuations, continuations in part, extensions and reexaminations thereof, and all rights therein provided by international treaties or conventions, and including the **ASSIGNOR**'s right to bring action and claim relief in respect of any infringement or unauthorized use of the Transferred IP Assets set forth in **Schedules A & B** whether occurring before, on, or after the date of this Confirmatory Assignment;


AND **ASSIGNOR** HEREBY confirms that **ASSIGNOR** has agreed and/or hereby agrees to sign any documents and to do all other things reasonably necessary to give effect to this Confirmatory Assignment as soon as reasonably practicable including to enable **ASSIGNEE** to fulfill all relevant national registry requirements for recordal of the assignment of the Transferred IP Assets set forth in **Schedules A & B** at those registries;

AND **ASSIGNOR** HEREBY authorizes and requests the Commissioner of Patents and Trademark of the United States, and the equivalent governmental authorities in any other jurisdiction applicable to the Transferred IP Assets set forth in **Schedules A & B** to record this Confirmatory Assignment;

AND **ASSIGNOR** HEREBY covenants and agrees with **ASSIGNEE**, its permitted successors and assigns, that **ASSIGNOR** had the right to convey all of **ASSIGNOR**'s interest confirmed herein or has the right to convey all of **ASSIGNOR**'s interest conveyed hereby, and that **ASSIGNOR** for a period of two (2) years following 12 June 2015 will use commercially reasonable efforts to ensure that copies of all correspondence that it receives, or its agents receive, relating to the registration and/or the use of the Transferred IP Assets set forth in **Schedules A & B** (including any notification received from any relevant registry or other third parties) are promptly delivered to **ASSIGNEE**;

AND **ASSIGNOR** HEREBY agrees with **ASSIGNEE** that, in the event of any conflict or inconsistency between the terms of this Confirmatory Assignments and either of the two prior agreements noted in the third paragraph herein, the terms of those prior agreements shall control;

AND **ASSIGNOR** HEREBY FURTHER covenants and agrees that this Confirmatory Assignment is effective as of 12 June 2015 for each of the Transferred IP Assets set forth in **Schedules A & B** hereto.

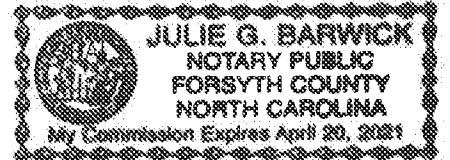
