ASSIGNMENT OF INVENTION AND U.S. PATENT APPLICATION

WHEREAS, I, David M. Stravitz, of 16 Park Avenue, Unit 14A, New York, NY 10016 (hereinafter referred to as the "Assignor") have invented certain new and useful improvements in a Eye Guard/Shield With Guide Channels, and

for which a provisional patent application was filed in the United States Patent and Trademark Office on August 7, 2019 and assigned serial No. 62/884,033; and

for which a provisional patent application was filed in the United States Patent and Trademark Office on November 15, 2019 and assigned serial No. 62/935,755; and

for which a nonprovisional utility patent application in the United States Patent and Trademark Office is about to be filed; or

for which a nonprovisional utility patent application was filed in the United States Patent and Trademark Office on March 13, 2020, and assigned Ser. No. 16/818,582 (I hereby grant my attorney the right to fill in the filing date and Serial No. of the application when known);

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to me, and/or other good and valuable consideration, the receipt of which is hereby acknowledged, I, the Assignor, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over unto the Assignee, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the invention and the provisional and nonprovisional patent applications, and all patent applications claiming priority thereof and divisionals, reissues, renewals and continuations thereof, and all patents of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for industrial property protection, including, without limitation, all applications for patents, utility models and designs which may hereafter be filed for the invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from the provisional and nonprovisional patent applications

under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for the invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and

I HEREBY authorize and request the Commissioner for Patents of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument; and

I HEREBY covenant and agree that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith; and

I HEREBY further covenant and agree that I will communicate to the Assignee, its successors, legal representatives and assigns, any facts known to me respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all design, divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the Assignee, its successors, legal representatives and assigns, to obtain and enforce proper protection for the invention in all countries.
