INTELLECTUAL PROPERTY TRANSFER AND LICENSE AGREEMENT

THIS INTELLECTUAL PROPERTY TRANSFER AND LICENSE AGREEMENT IS MADE ON 28 MARCH 2019
BY AND BETWEEN:

- (1) Koninklijke Philips N.V., having its registered office at High Tech Campus 5, Eindhoven, the Netherlands ("Seller"), and
- (2) Philips Photonics GmbH, having its registered office at Lise-Meitner-Strasse 13, 89081 Ulm, Germany ("Company");

Seller and Company hereinafter individually referred to as a "Party", and collectively as the "Parties".

WHEREAS:

Seller and TRUMPF International Beteiligungs-GmbH have entered into a sale and purchase Agreement dated 14 December 2018 ("the Principal Agreement") for the sale and purchase of the Business (as defined in the Principal Agreement);

In connection with the Principal Agreement, Seller and Company wish to confirm their agreement concerning the assignment and licensing of intellectual property rights whereby Seller will: (i) assign, or cause its Affiliates to assign, certain intellectual property rights related to the Business, and (ii) grant, or cause its Affiliates to grant, a license under certain intellectual property rights related to the Business.

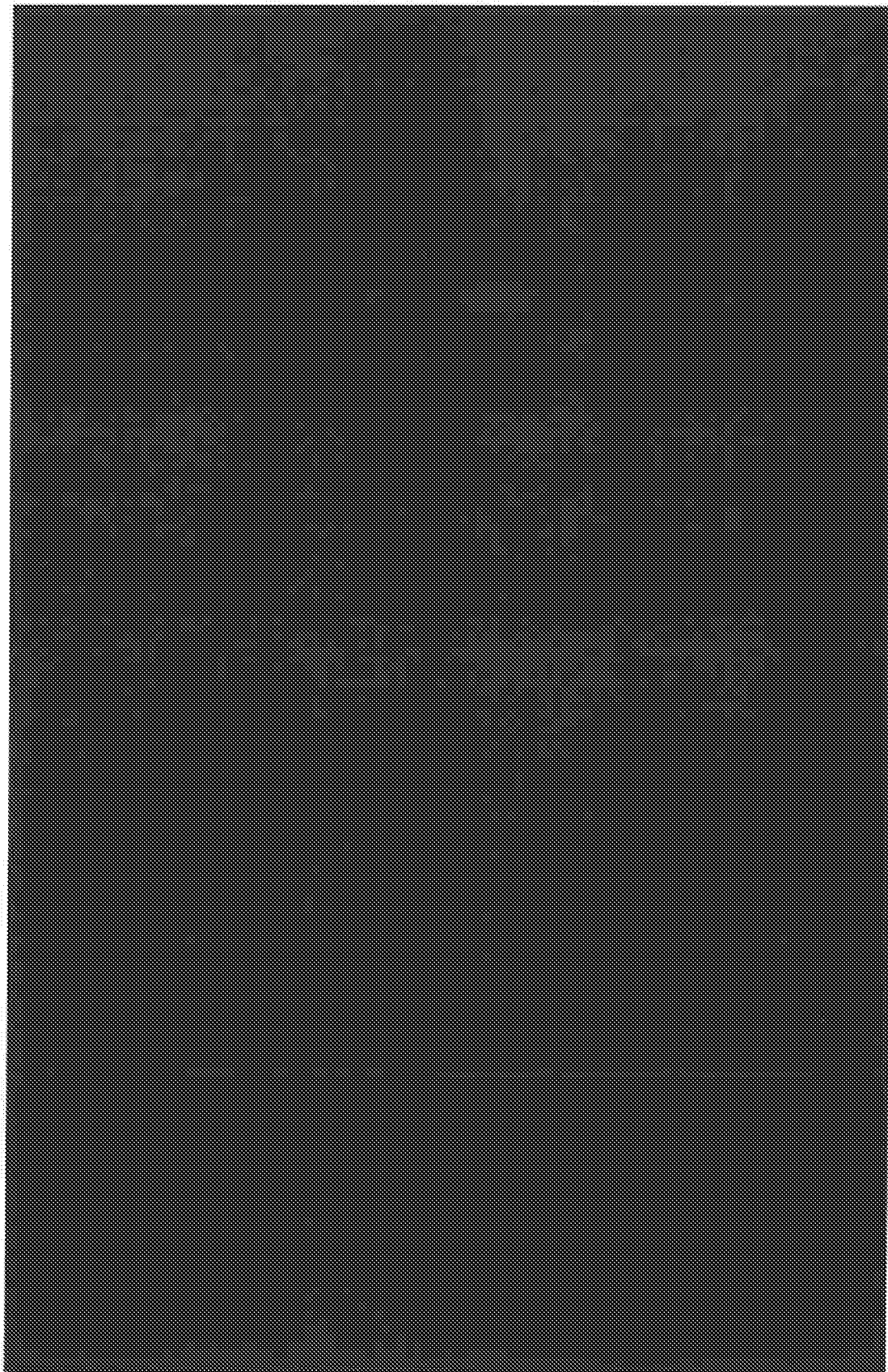
IT IS HEREBY AGREED AS FOLLOWS:

1. Definitions

When used in this Intellectual Property Transfer and License Agreement ("Agreement"), the following terms shall have the meanings set forth below:

"Patent(s)" shall mean all patents, utility models, and all applications for such rights, and undisclosed inventions (as well as all patents and patent applications that may issue therefrom), as well as any divisionals, re-issues, renewals, re-examinations, continuations, continuations-in-part and foreign counterparts of any of the foregoing;

"Transfer Patents" shall mean any Patent listed in Annex A-1 and Annex A-2 to this Agreement, including any Patent on invention disclosures listed in Annex A-3 to this Agreement;

Any capitalized term used in this Agreement but not defined shall have the same meaning as ascribed thereto in the Principal Agreement.

2. Assignment of Transfer Patents

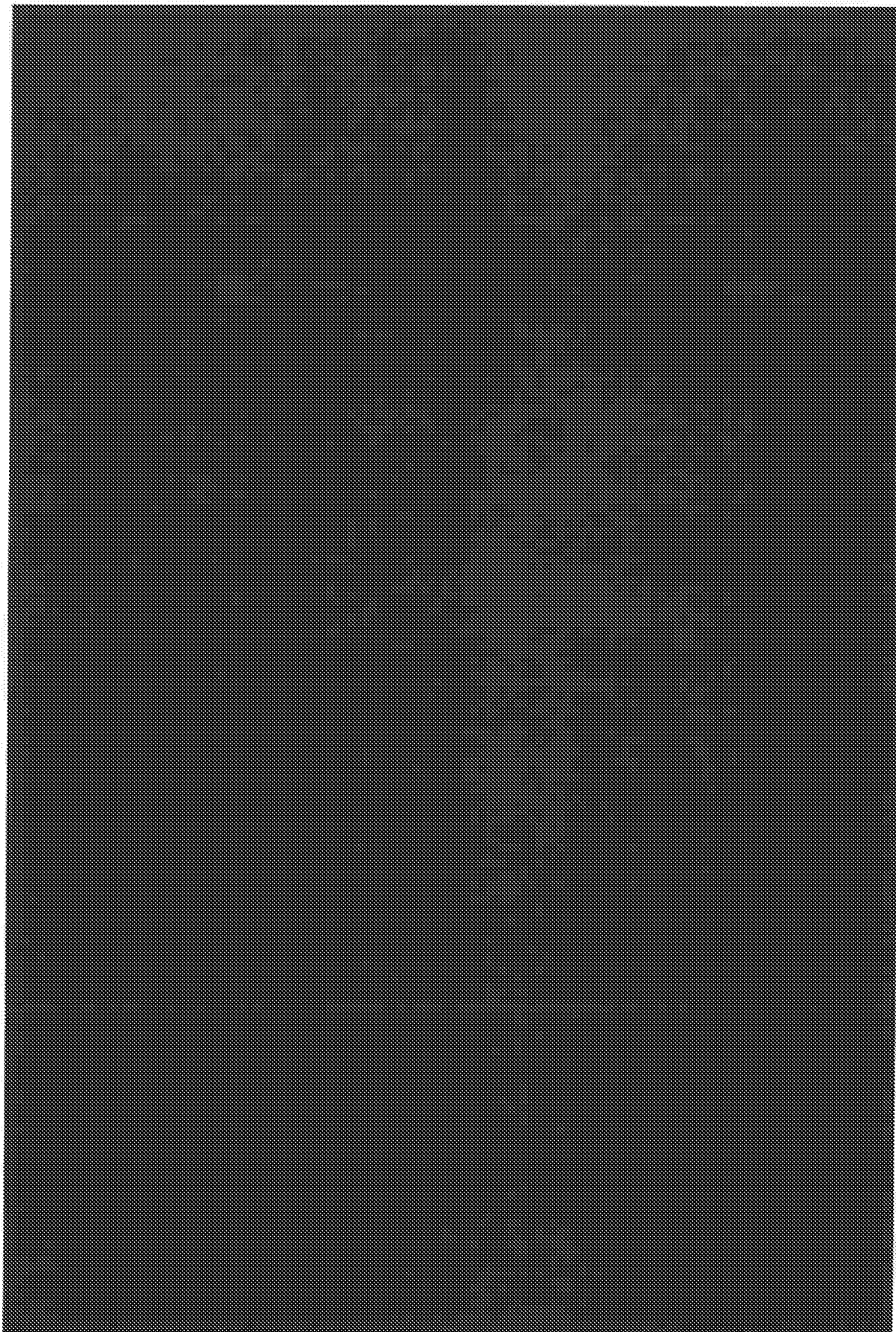
2.1 Upon Completion in accordance with the Principal Agreement and subject to the provisions of this Clause 2, Seller hereby assigns and agrees to cause its relevant Affiliates to assign to Company the Transfer Patents (in case of Patents solely owned by Seller) respectively Seller's share of the Transfer Patents (in case of Patents which are owned jointly by Seller and any third party)

2.2 Company shall be responsible for the recordal of the assignment and bear all costs related to the registration of the assignment of the Transfer Patents. Seller shall sign and execute all such documents and do all such things as are necessary for the assignment of the Transfer Patents respectively Seller's share of the Transfer Patents to Company under this Agreement.

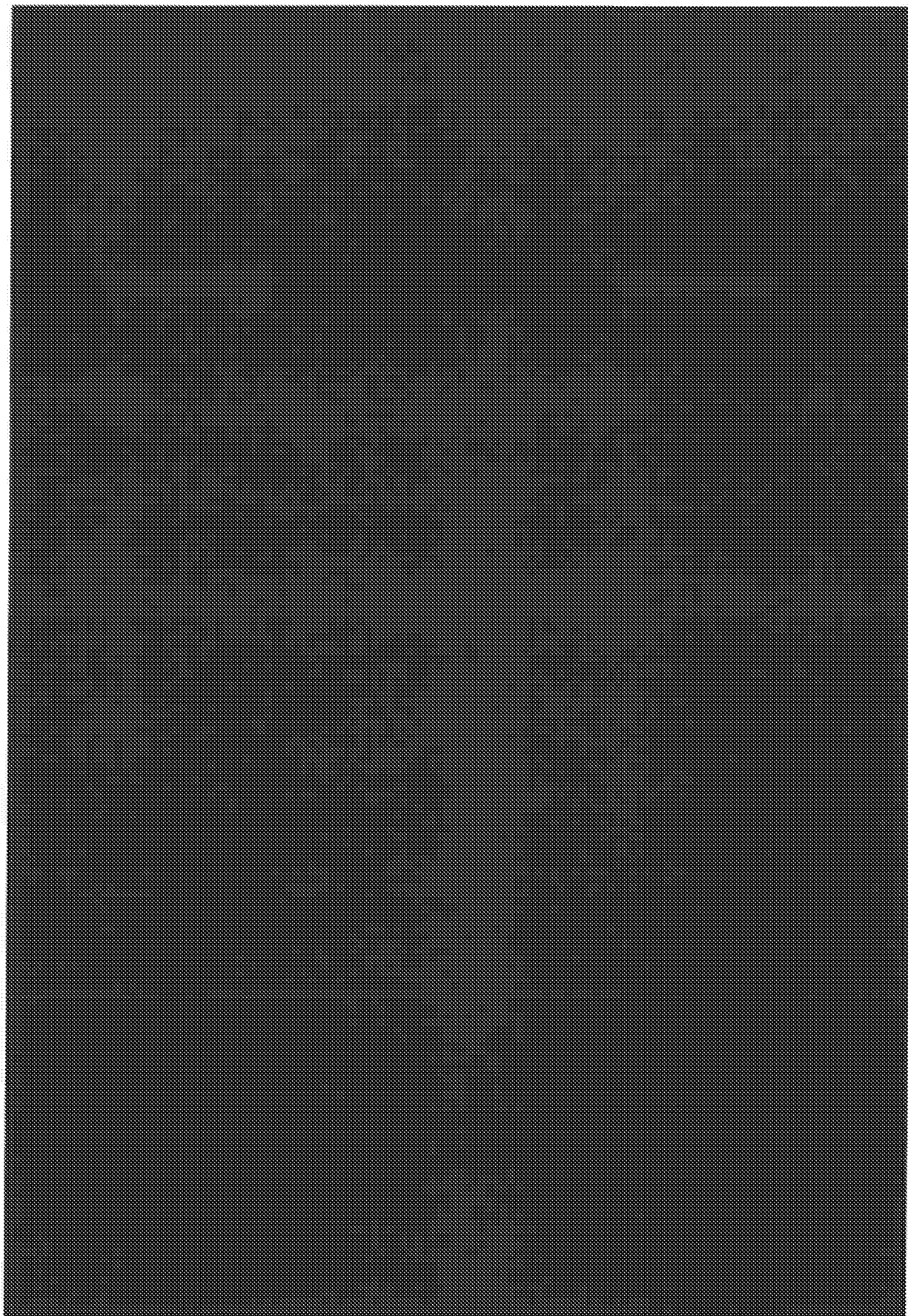
As from the Completion Date, Company may at its sole discretion end the prosecution, maintenance and other handling of the Transfer Patents.

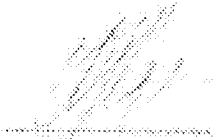
15 Execution; Delivery
